## Release, Waiver of Liability, Assumption of Risk and Indemnity Agreement:

I wish to participate in Lake Sawyer Hawks Radio Control Model Flying Club ("Hawks") activities. I understand Hawks activities involve inherent risks including weather, equipment failure, collisions, loss of control, falls, acts/omissions of participants/spectators, and limited medical access. I voluntarily accept all such risks and any resulting injury (including death), property damage, or loss.

Release (Adults): To the fullest extent permitted by Washington law, I release and agree not to sue Hawks, its directors, officers, instructors, members, volunteers, event organizers, landowners (including King County), and agents ("Released Parties") for claims from my participation, including ordinary negligence claims. This excludes claims that cannot legally be released, including gross negligence or willful/reckless misconduct.

Indemnity: I agree to defend, indemnify, and hold harmless the Released Parties from third-party claims/liabilities (including attorneys' fees) arising from my participation.

Medical Authorization: I authorize emergency medical care as deemed necessary. I am responsible for all costs.

Rules: I agree to follow all Hawks, AMA, and site-specific rules and instructions from officials/staff.

Governing Law: This Agreement is governed by Washington law. Exclusive venue: King County, Washington courts. If any provision is invalid, the remainder is enforced.

Acknowledgment: I am 18+ years old, legally competent, have read this Agreement, understand it, and sign voluntarily.

## Safety Rules and Regulations Acknowledgements

1. SAFETY IS THE FIRST PRIORITY. Do not fly in a reckless, careless, or dangerous manner.
2. Smoking is NOT allowed anywhere, anytime within the fenced area.
3. No fires allowed anywhere, anytime within fenced area.
4. Alcoholic beverages or other legal intoxicating substances are NOT ALLOWED within the fenced area.
5. No RC aircraft shall display any hate markings.
6. Maximum model weight is 20 pounds.
7. AMA Membership is mandatory for all pilots and must be valid.
8. You must be a current Lake Sawyer Hawks Member to fly, unless a guest of a member.
9. New members must demonstrate proficiency before flying solo.
10. All flights will be within the fenced area of Anderson Field.
11. Intentional flying behind the pits is prohibited.
12. If you are sharing a frequency, inform other pilots of the frequency you are using.
13. All new, repaired, or altered aircraft will be range checked and undergo a safety inspection prior to flight.
14. All aircraft must have identification as required by FAA and AMA. Pilots are responsible for meeting FAA requirements.
15. A maximum of four aircraft on the flight line at once.
16. One flyer per flight station. Using a spotter is recommended.
17. The east-west runway is only used for takeoffs.
18. The main runway can be used for takeoffs and landings.
19. Pilots must announce intentions to other active flyers (e.g. "taking off," "landing," "dead stick," "on the runway").
20. Pilots will give right of way to, and avoid flying near, full-scale aircraft.
21. Spectators and pets must remain in the grassy area west of the pit area or in the parking area.
22. All powered aircraft shall be electric powered (no internal combustion engines allowed).
23. Electric aircraft must produce sound levels at or below 79db at 25 feet.
24. Motors are to be shut down near the flight station. No taxiing into the pit area.
25. Clean up your area. If you pack it in, pack it out.
26. Pilots are liable and financially responsible for their aircraft's actions and any damages caused.
27. No overnight camping.
28. Have a great day flying and take care of everyone around you.
